REQUEST FOR DISPENSATIONS.

REPORTS:

- a) VAS was in use in June and will return in September
- b) There was no further update on the Village Hall repairs
- c) The road that floods outside Valley Vineyards. TG previously advised that works are expected within the 21/22 budget year. No updates received. Clerk asked to chase SCC for progress again.
- d) Reports of a possible unauthorised fibreglass factory/workshop are still with planning to investigate. Clerk asked to progress again,
- e) The Beck supports collapsing. Already reported several times by the Clerk on the reporting website and been advised not SCC responsibility. Suggested may be Environment Agency, Clerk and AC to enquire.
- f) "Feed The Bees" signs are not currently available from SCC and may be available in the future, but at a cost.

It was resolved, in principle, to accept any funds and inventory from the Wissett Community Council should their meeting of 31st August 2021 resolve to formally wind up. Any monies held would be used for the intended charitable reasons of the WCC. The proposed storage facility on the village field to hold the inventory would be considered for viability looking at
