- c) The road that floods outside Valley Vineyards. TG advised that works are expected within the 21/22 budget year.
- d) Trees on the village field. MW and CP have looked and will do some trimming soon. May ask for volunteers in April to weed / rake the hedge between the fields.

- f) 5 The Street windows. Planning have advised cannot enforce until retrospective planning expires in February 2023.
